Preamble

This Glossary contains terms and expressions used in the CIT Documents for International Rail Passenger Traffic as well as in the Uniform Rules concerning the Contract of International Carriage of Passengers by Rail (CIV) and the Regulation (EU) No 2021/782 of the European Parliament and of the Council of 29 April 2021 on rail passengers' rights and obligations (PRR).

Some of "alias" (synonym terms) and "associated terms" indicated in the Glossary are based on further legislation and sector standards (e. g. TAP-TSI, UIC IRS etc).

For explanations of abbreviations please consult the document "List of abbreviations" on https://www.cit-rail.org/en/cit-tools/. Detailed explanations of relevant UIC Leaflets/UIC IRS are to be found in the Manual for International Rail Tickets (MIRT), Chapter 5.

The descriptions/explanations given for the actors involved in international ticketing (e.g. "distributor") are not intended to give authoritative definitions for all regulatory purposes but they rather attempt to make a contribution to transparency. More detailed explanations of the actors and their definitions applied by different regulations and industry standards are to be found in the MIRT, Chapter 3.
